- Represents additional performance-based shares of Restricted Common Stock that vested on February 24, 2023 whose grant was originally reported on a Form 4 filed with the Securities and Exchange Commission on January 13, 2020 (the "Original Form 4"). As reported on the Original Form 4, such performance-based shares were originally granted to the Reporting Person based on the Company's Return on Invested Capital achieved by the Company compared to the ROIC target with the final number of performance-based shares varying from 0 to 200% of 8,655. The Return on Invested Capital achieved by the Company compared to the ROIC target yielded 200% payout. As a result, 8,655 additional ROIC Performance Shares were issued.
